

### The History of Fire Prevention Week

Preventing the devastating and deadly effects of fires is considered the fire service's most important role in the community. While this effort is carried on throughout the year, a one week period of each year is designated as Fire Prevention Week.

Many people wonder why this certain week is set aside for recognition of this important message. In 1911, the Fire Marshals Association of North America decided the 40th anniversary of the Great Chicago Fire should be observed in a manner to inform the public about fire prevention and fire safety and Fire Prevention Day was observed on October 11, 1911. In 1920, President Woodrow Wilson issued the first National Fire Prevention Day proclamation. Then, in 1925, President Calvin Coolidge proclaimed the first Fire Prevention Week as October 4-10. Although the original anniversary was set to recognize the Great Chicago Fire, which took the lives of more than 200 people, destroyed over 2,000 acres of land and nearly 18,000 buildings causing approximately \$200 million in property damage, little recognition was given to another, more deadly and destructive fire, that took place that very day, the Peshtigo (WI) Fire. The Peshtigo Fire, although mostly forgotten, resulted in over 1,875 square miles or 1.2 million acres of forest being consumed, an area approximately twice the size of the state of Rhode Island. In addition, twelve towns were destroyed. Although an accurate death toll has never been determined since local population records were destroyed in the fire, estimates of between 1,200 and 2,500 people are thought to have lost their lives.

Each year, the National Fire Protection Association(NFPA) chooses a fire safety topic to promote and provides informational materials to fire departments across the country in a effort to standardize the fire safety message.

## **Department Information**

The Central Stickney Fire Protection District provides fire suppression, rescue and emergency medical services to our residents, business, and visitors within an area of 4.78 sq. miles. In addition, we respond on a mutual aid basis to any community within Division 21 as part of the Mutual Aid Box Alarm System (MABAS) and on a reciprocal agreement program known as a "Full Assignment" to the surrounding communities of Bedford Park and Summit and Stickney for all structure fires. In return, these communities respond to our community when requested.

# Staffing

When fully staffed, The Central Stickney Fire Protection District maintains four members per shift on a 24-hour, 7-day-a-week schedule. Offduty personnel, including paid-on-call firefighters, are also notified by pager when staffing levels at the station fall below a pre-established minimum or when the department responds to a report of an emergency incident. In the future we hope to have additional members on shift. Residents have asked what the pay scale is for our firefighters. The Crew made up of 4 members includes 2 Firefighter/Paramedics and 2 Firefighters. The member's hourly rate is \$11.25 per hour for Paramedic Shifts and \$8.25 per hour for Firefighter Shifts.

# **Emergency Medical Services Report**



Emergency Medical Services (EMS) continues to be a major part of our response profile. By way of utilizing flexible staffing, the Central Stickney Fire Protection District is able to provide Paramedic level services with Ambulance 909, our primary paramedic unit. Ambulance 908, a secondary unit as a spare vehicle if the primary vehicle requires maintenance, and finally all our Fire Apparatus is equipped with First Responder medical equipment that is available to initiate treatment until a fully staffed Ambulance unit can intercept and continue treatment. Ultimately the citizens can appreciate a high level of service when requesting medical care.

# Apparatus / Equipment Maintenance Report

One of the most frequent compliments paid to members of our Department is the extremely clean and well-kept appearance of both our apparatus and fire station. Visitors are often impressed at the condition of our apparatus and are shocked to learn their high level of use. The fact is, members of our Department take great pride in taking care of both the apparatus and station and respect the fact that we proudly take on the task of maintaining the equipment that belongs to the citizens of Central Stickney, not the members of the department. ### Training Report

The Training Bureau is managed by the department Training Officer whose primary responsibility is to organize, develop and schedule training for all department members in compliance with federal, state or local requirements. The goal of the training bureau has been, and will continue to be, to provide all employees with quality training that is specific to their job description and needs, yet provides them with the knowledge, skills and abilities to fulfill the mission of the department. Funding for training is provided by a budget line item that not only reflects the District's commitment to maintaining well trained employees, but the department's dedication to providing the best trained "customer service" delivery force available.

Training is provided to all shifts Monday through Sunday by their respective Officer or another carefully chosen "expert" in the topic. Much of the training information is taken from the International Fire Service Training Association (IFSTA) texts or based on NFPA standards and locally or nationally recognized acceptable practices.

Because of the unique cross-staffing situation utilized by the department, all members are cross-trained in all aspects of every position.

Many training activities take place at locations remote from the fire station.

These sites included the Illinois Fire Service Institute, Cicero Fire Department Burn Tower, Division 21 fire stations, and any acquired residences.

Also our department participates in several multi-department-wide drills. This training is intended to have the entire department train together on common topics with the surrounding community's firefighters.



## Equipment Purchases and Upgrades

In 2016, the department made several purchases and upgrades in an effort to improve the safety and efficiency of our operations.

- \* All SCBA's (Self Contained Breathing Apparatus) had preventative maintenance completed. (a maintenance that is required every year).
- \* 2 new portable radios were purchased to replace old and outdated models.
- \* A new Thermal Imaging Camera was purchased. This camera can help firefighters see through smoke, assist with finding hidden fire and search and rescue
- \* A new computer was purchased for our training room. In this computer and internet world, we wanted to keep our firefighters up to date and give them the ability to train using the newest methods. Our training room has a projector and the ability for the firefighters to use the equipment for webcasts, power point presentations and videos.
- \* The Apparatus Bay Floor was painted. (First time in over 20 years)
- \* 600 feet of Firefighting hose was replaced.
- \* A new Hurst RAM tool was purchased to replace our old unit that was 21 years old. This new RAM is part of our vehicle extrication equipment.
- \* With the help of State Grants our Firehouse lighting was upgraded to all LED lighting. In addition to the cost savings of replacement bulbs we have already seen a substantial decrease in our Electric bill.



# Public Education Report

The Central Stickney Fire Prevention Bureau is also responsible for Public Education. The purpose for public education and public safety is to inform all residents and business occupants of current public education opportunities and safety issues as well as any new safety requirements.

The Fire Prevention Bureau conducts numerous events year round to keep the community informed. We use the marquee sign to communicate any events, educational opportunities, and other important information as needed.

#### **Fire Prevention Week**

The students from Sahs School are able to take a field trip to the firehouse during this week to learn firsthand about fire safety from the firefighters. They take a tour, look at the equipment and apparatus as well as try on the fire gear with the help of the firefighters. The students usually experience the Fire Safety House however this trailer was in poor condition and was removed from service. This trailer was donated to our department and we made great use of it for years. We will continue to look for opportunities to replace it via grants and donations.

#### **Open House**

The CSFPD opens the doors to the community one day a year in October. During this time, we offer fire safety presentations to families as well as tours. There are brochures available filled with information to take home. Children are given the chance to spray water from the hose to put out the little house fire. Food is provided, and it is also a great time to have your blood pressure checked.

#### Department siren use

We no longer use our siren for emergency calls however The siren is used for tornado warnings. If the pitch is constant it has been activated for a tornado warning. The tornado siren is only activated when a tornado has been spotted within 30 miles of our community. It is also tested every first Thursday of the month at 10:00am

#### Santa Around Town

Santa joins the firemen of CSFPD as we parade around the town with the engine, ambulance, and truck to spread holiday cheer.

We have joined the social media craze, and we have a Facebook page. Our firefighter's association has one as well.

## Fire Inspection Report

The purpose of the Central Stickney Fire Prevention Bureau is to inform all current business occupants as well as prospective business owners on the initial requirements as well as ongoing requirements that will be enforced on a yearly basis.

**Our** fire protection district covers roughly 5 square miles encompassing unincorporated Cook County Stickney Township. If your occupancy falls within our districts, please feel free to contact us at the fire station with any questions during normal business hours.

The Fire Prevention Bureau shall be the Authority Having Jurisdiction (AHJ) and is responsible for all Life Safety and Fire Prevention code enforcement and the review of all such related plans. Our bureau works in conjunction with the Cook County Building Department and will ensure all business are up to current standards prior to issuing any Occupancy Permits for all occupancies as listed below, located within our fire district. Any commercial / mercantile occupancy as well as multi-family occupancies of three or more units shall be compliant with the codes and ordinances that have been adopted by the Fire Protection District.

**Initial Inspection / Occupancy Permit** 

All new construction and changes of use or occupant shall require an inspection that will ensure the occupancy is compliant with current standards. This inspection shall be forwarded to the Cook County Building Department.

**Annual Fire Inspections** 

All existing occupancies shall have a fire inspection completed annually.

**Biannual Fire Preplans** 

All existing occupancies shall have a fire preplan completed biannually.

Fire Alarms

All applicable commercial / mercantile occupancies shall have a fire alarm installed in accordance with NFPA 72. The fire alarm system shall be tested by a licensed company annually. This certificate shall be on hand at all times.

Fire Alarm Monitoring

All fire alarms shall be monitored directly by our dispatch center in Oak Lawn via ADT Alarms.

Fire Sprinkler System Requirements

A fire sprinkler system is required as follows: Any new building that is fire thousand (5,000) Sq. Ft. or more, any existing building, when any addition and / or additions are constructed increasing the new total Sq. footage of the building to exceed five thousand (5,000) Sq. Ft. or more, and any change of use / occupancy type of building already exceeding five thousand (5,000) Sq. Ft.

The fire suppression system shall be tested by a licensed company annually. This certificate shall be on hand at all times. If the suppression system contains a fire pump, the fire pump shall be tested by a licensed company annually. This certificate shall be on hand at all times.

**Knox Box Requirements** 

All commercial / mercantile occupancies that have a fire alarm of fire suppression shall have a Knox Box installed on its building.

The Knox Box shall be located on the exterior of the building at the direction of the bureau and shall be installed 60" above final grade.

A Knox Box Pad Lock will be required for any exterior gates that access the building.

The Knox Box shall have a current set of keys for the occupancy to access ALL parts of the building.

New Requirements for 2010

Effective January 1, 2010 <u>ALL</u> Commercial Kitchen Suppression System must be changed over to UL 300. For more details visit the Office of Illinois States Fire Marshal website.
